Please note we do not accept any soil from existing or previously occupied service station or factory or industrially used sites or similar without full environmental results as these sites are automatically deemed to require proper testing in accordance with the EPA guidelines. Any suspect material will be turned away or reloaded on the delivery truck and our GATEHOUSE OPERATOR is here nominated as REFEREE to inspect and deem any load unsuitable for tipping at our facility. ROCK AND DIRT RECYCLING reserves the right to change any of our conditions at anytime without notice.
